MATCH IS INSIDE ON PACKED DIRT

Match starts at 3:00 PM

Entry Fee: \$10 Each Run (maximum of 2 runs per dog)

Match Opens Wednesday, May 21, 2008, at 9:00 AM. Entries Close  
Wednesday, June 25, 2008 at 4:00 PM or such time as the limit is reached.  
Entries cannot be changed or cancelled and no refunds will be issued after  
entries close. No entries will be accepted at the trial. No email entries  
accepted.

Confirmations provided by email only. Entries that can not be accepted will  
not be returned. They will be shredded along with checks submitted. Checks

Match will begin at 3:00 PM.

Courses will be nested, so all classes will run together within a jump height.

JWW will run high to low jump heights.

Standard will run low to high jump heights.

### *RULES/Additional Info*

- ❖ No FOOD in Ring.
- ❖ No Prizes or Ribbons.
- ❖ Dogs may enter "FEO" e.g. "For Exhibition Only"
- ❖ Dogs can enter Level ABOVE their current level (not below)
- ❖ 2 runs per dog allowed..

Reasonable Training Allowed in Ring -- There shall be no drilling nor intensive or  
abusive training of dogs on the grounds of a Plan A or Plan B Sanctioned Match.

At Plan B Sanctioned Matches, while dogs in the ring may receive verbal corrections,  
such corrections shall be penalized. The judge shall not allow harsh corrections in the  
ring. In addition, the judge of a Plan B Sanctioned Match may, at his own discretion,  
permit a handler and dog to repeat an exercise; however, only the first performance shall  
be scored, unless the dog is being re-judged on the exercise because in the judge's  
opinion the dog's performance was prejudiced by peculiar and unusual conditions.  
Exhibitors must follow the judge's verbal instructions.

- ❖ Runs are subject to Maximum Course Time
- ❖ This trial is open to all dogs over the age of 15 months that are  
registered with the American Kennel Club, have Limited Registration, or  
have an ILP, PAL or FSS number. AKC Numbers are NOT required. You  
will state your dog's breed on the entry form. No FOOD in Ring. AGAIN  
NO FOOD IN RING.

- ❖ We will have a SEPARATE worker raffle for those who help work the B  
Match.
- ❖ You may bring a toy in the ring but the toy may NOT be thrown.

### DIRECTIONS TO MATCH SITE

**From Atlanta (or North): Take I-75 South to the Macon By-Pass  
(I-475). Take the Macon By-Pass. It will put you back on I-75  
South. Take Exit #135. Turn left to the Agricenter. Enter at the  
East Gate.**

**From South: Take I-75 North to Exit #135. Turn right left to the  
Agricenter. Enter at the East Gate.**

**Parking is permitted in designated areas only. Parking is not  
permitted in the area to the front of Reeves Arena (toward the  
lakes and clock tower). Parking behind Reeves is reserved for  
judges and trial committee.**

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
